SUBJECT: King Turkey Day Celebration

This year, Worthington is celebrating its 84th year of King Turkey Day on Friday, September and Saturday, September 15th & 16th 2023. In efforts to continue growing, we are already making plans and commitments. This year's activities will begin at 4pm on Friday and will be located downtown Worthington. We are asking all food vendors to be set up and ready to sell by that time. Late arrivals will NOT be accepted and no refund will be given.

In addition to the vendor fee, we are asking for a separate check of \$100.00 – to be used as a deposit. This deposit will be used for vendors running out of food, leaving early or leaving garbage (oil, appliances, etc.) after festivities are over on Saturday night. Deposit checks will be returned if no violations. We also ask that when setting up Friday, you do not stuff the garbage receptacles full of your garbage – please be courteous to the crowd that will be attending.

We will be honoring registrations as they come in first come first serve, so don't delay. We will be trying to limit one specialty item per one vendor.... another reason NOT to delay. (Example: one kettle corn vendor, one taco vendor, one ice cream vendor, etc.). You will be notified if your registration was accepted.

YOU ARE REQUIRED TO BRING 50' OF HEAVY-DUTY CORD TO ADEQUATELY CARRY YOUR OWN ELECTRICAL NEEDS. Power is at a premium, so plan ahead....no household extension cords, but generators are welcome. See attached picture.

You will need to contact Ryan Miller, Minnesota Department of Health at 507-344-2721 for a special event license in MN. You cannot set up without the proper license. Pepsi has an exclusive on all soft drinks. Meaning, you have to sell Pepsi products only if you are selling soft drinks. Please contact Tim Haubrich at (507) 825-4207 if you need to place an order.
